8. **Community Updates:** The "We are Laurel Canyon" annual meeting will feature Mayor Karen Bass and Fire Chief Jaime Moore. The MySafe:LA Wildfire survey is an important opportunity to move L.A. forward with new kinds of support. The MySafe:LA/LAFD wildfire evacuation training workshops will begin in September.
